

B1 column and wall construction










Ground floor slab progress

GF – L1 column progress




Ground floor slab progress







Level 1 decking progress





Works completed in previous 12 weeks

- Manhole and drainage construction continued.
- Vent tunnel works completed.
- Trimming of Albany Court wall protrusions completed.
- Poured basement (Level -2).
- Continued the removal of temporary works.
- Continued columns and liner wall concrete pours.
- Slipform operation complete and rig dismantled.
- Sackville Street gantry removed.
- Basement slab pours completed.
- Additional welfare cabins installed.

12 week look ahead

Scheduled works for the next 12 weeks

Temporary works

- Propping liner walls on Sackville Street elevation.
- A-Frame remedial works.
- Propping and removal of floor slabs in sequence.
- Removal of No. 36 Sackville Street steel work.
- Removal of façade retention steel work in sequence.

Substructure works

- B1 to GF liner walls will complete.
- GF slab will complete.


Superstructure

- Concrete column pours.
- Concrete core capping slab pours.
- Level 1 post tensioned slabs will commence.
- Blockwork will continue.
- Façade works to commence.
- Mechanical and electrical plant deliveries to commence.
- Post-tensioned slabs will commence.
- Installation of north core precast concrete panels.

Notable works

Works visible / audible at perimeter of site

- Slab pre-pour clean
 - Before concrete is poured it is essential that the rebar is blown out to remove any binding wire as well as debris left on the decking.
 - This prevents structural and aesthetic issues post pour.
- North Core precast panels
 - During install of the precast panels, drilling and fixing temporary props is required to ensure the stability of the structure is not affected.






Initiatives

- McLaren have introduced Alex Talks our Community Liaison Coordinator. Alex will be taking the lead on all community matters, answering all queries relating to the project and ensuring all members of the community are communicated to with updates and relevant information in a timely manner.
- Inspections of the site boundary will be completed daily. Any observations and required actions will be recorded. Alex will also respond to any observations reported by 3rd parties.
- Newsletters and CLG meetings will continue.
- McLaren will be issuing notification to local residents of Saturday works in advance of them taking place with a four week look ahead issued at the same time.
- The works have been sequenced to complete the blockwork on Sackville St. and Albany Court as early as possible to create an additional acoustic and dust barrier.
- Over the coming weeks and months McLaren will constantly review the operations and look at new initiatives to support the community, we will continue to use this meeting as an opportunity to share them.
