Good progress was made across multiple work streams on site throughout February.

Mini piling is practically

complete in Nuffield House



In the next period, our key focuses are to complete the lower waler beam installations along Albany Court and 36 Sackville Street as well as the B2 thrust block.

These work activities are important as it releases the next phase of piling and excavation works in Pegasus House.

On Thursday 7<sup>th</sup> March, Conway will be closing Sackville Street to undertake resurfacing works on behalf of Westminster City Council. This is expected to continue until the 26<sup>th</sup> April.

To ensure site progress continues, McLaren have agreed a temporary traffic management plan with Westminster. Vehicles will drive into Sackville Street as normal and will then reverse back out on to Piccadilly with strict procedures in place to manage both traffic and the public.

  - Lower waler beam installation to 36 Sackville Street and Albany Court.
  - Raking prop remediation in Nuffield House.
  - Reducing level in Pegasus House.
- Perimeter scaffold installation continues.
